Statement in support of factual contentions made under Section 5 of the attached Michigan Department of State Campaign Finance Complaint Form:

On Friday, May 9, 2014, the Committee to Retain Leo Savoie Bloomfield Township Supervisor, Committee I.D. Number 95490, filed with the Elections Division of the Oakland County Clerk's office, received a contribution in the amount of \$2,500.00 from a corporation: Hubbell, Roth & Clark, Inc., P.O. Box 824, Bloomfield Hills, MI 48303.

The tender and receipt of said contribution was intended to improperly influence the sponsorship and passage of a controversial and procedurally improper award of a sewer contract for the Upper Long Lake Estates Long Pointe Drive Sanitary Sewer Extension which was placed on the Monday, May 12, 2014 Bloomfield Township Board of Trustees meeting agenda by Bloomfield Township Supervisor Leo C. Savoie whose candidate committee was the recipient of said contribution the immediate Friday before the meeting.

Bids for said contract were solicited by Bloomfield Township's Engineering Department with the assistance and review of the donor of said contribution, Hubbell, Roth & Clark, Inc., without prior knowledge or authorization of the Bloomfield Township Board of Trustees in violation of past practice and procedure and in violation of Bloomfield Township's Purchasing Policy. (See attached policy)

The award of said sewer contract was finally approved on a split vote by the Bloomfield Township Board of Trustees at a subsequent meeting held on June 23, 2014 after many members of the public spoke both in favor and in opposition of the sewer project.

Allegations of wrongdoing were leveled by the public against members of the Bloomfield Township Board of Trustees, the Engineering Department and Hubbell, Roth & Clark at the time of the initial meeting on the topic, subsequent public meetings and throughout the final Bloomfield Township Board of Trustees meeting on the topic held on July 14, 2014. All of these public meetings are available for viewing in their entirety on video through the Bloomfield Township website.

Throughout the entire controversy, Bloomfield Township Supervisor Leo C. Savoie claimed that there was no wrongdoing on his part and that all he wanted to do was to do something nice for some people.

Supervisor Savoie never disclosed the fact that his campaign committee had received a \$2,500.00 contribution a mere 3 days before he brought forward the sewer contract for approval wherein the donor, Hubbell, Roth & Clark, Inc. stood to gain monetary reward from their scope as consulting engineers on the sewer project. Supervisor Savoie is not even up for election until 2016 so the timing of the contribution is even more suspect and he was surprised that he had to file a campaign committee statement by July 25, 2014 as required by the amended campaign laws. Otherwise the contribution would not have been disclosed to the public until January 31, 2015 as per the old law. The dust would have settled by then and the sewer project would have been completed.



Bloomfield Township Supervisor Savoie had ample time to reconsider the receipt of the campaign contribution in order to return it within 30 days of receipt. At a minimum, Supervisor Savoie had a duty to disclose to the Bloomfield Township Board of Trustees and to the public his receipt of the contribution and to recuse himself from any vote on the topic of the sewer project. He had ample time and opportunity to do so throughout the several public meetings on the issue. He chose rather to deny any improper conduct and continued to advocate for the award of the sewer contract until he finally had the bare majority votes of the Bloomfield Township Board of Trustees necessary to proceed with the sewer project.

On the face of the facts, it appears that a bribe was tendered by Hubbell, Roth & Clark, Inc. and received by Bloomfield Township Supervisor Leo C. Savoie through his campaign committee in order to secure passage of approval for the Long Pointe Drive Sewer project in contravention of the statutes of the State of Michigan and in violation of the public trust.

I respectfully request that the Secretary of State and the Attorney General for the State of Michigan investigate these matters to determine the extent of wrongdoing, if any, by Bloomfield Township Supervisor Leo C. Savoie, his campaign committee and Hubbell, Roth & Clark, Inc. and to render the appropriate civil and/or criminal justice required by law and expected by the public.
