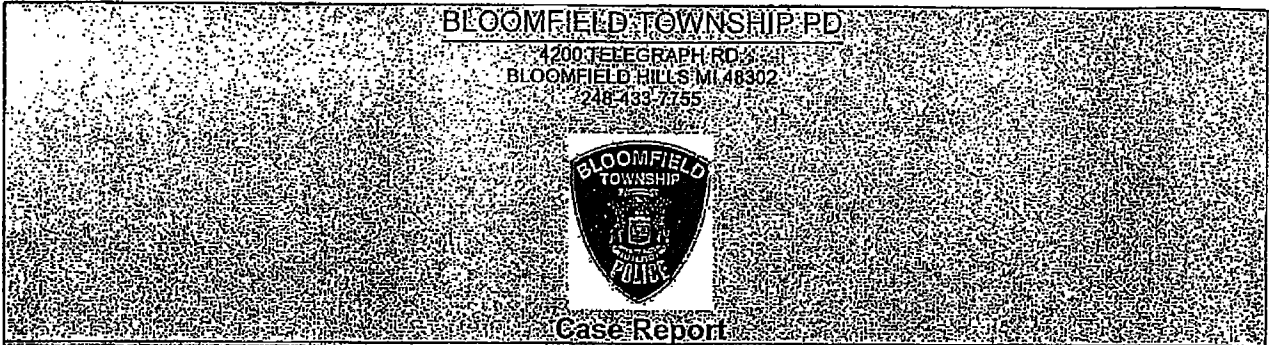

Narrative

On the above date at approximately 1pm I met with Dan Devine in reference to a suspicious circumstance involving his daughter [REDACTED] Devine. Dan stated that [REDACTED] was scheduled to work as a Nanny today. This morning at approx. 7am, he spoke with [REDACTED] through her bedroom door. Dan ended the conversation and continued with his personal matters. He went



outside later that morning and noticed that [REDACTED] pink Chevrolet was gone. He assumed that she drove it to her Nanny job. A few minutes later, he received a call from the family for whom she was to Nanny. He was told that [REDACTED] did not arrive for work. Dan attempted to call [REDACTED] on her cell phone and did not receive an answer. Dan was concerned that foul play may be the reason why [REDACTED] was not at her Nanny job or answering her phone. Dan added that [REDACTED] also works for a substitute teacher company who services area schools. He believed the name of the company is EduServe.

I attempted to find a number for EduServe and could not find any company matching his description. I then called Bloomfield Hills schools and was told that [REDACTED] was not working for their schools today but their computers showed her working today in another district. I was given a telephone number for EduStaff which is the temp service that [REDACTED] works for. I called EduStaff and was told that [REDACTED] was scheduled to work until 12pm at Keller Elementary in Royal Oak. I called Keller Elementary who confirmed that [REDACTED] did work her scheduled hours today.

Dan was satisfied with our findings and did not want anymore follow up done. He said he will contact our department when he speaks to [REDACTED].

Dan called our department at approx 4pm stating that he spoke with his daughter and everything was fine.

Captain Langmeyer,

On Friday May 1, 2015 at approx. 1300 hours Dan Devine walked into the lunch room where Sgt. Weise and I were eating lunch. Dan walked over to us and said "I think I have an emergency ". When I looked at Dan he appeared to have a scared/ wild look to his glassy watery eyes. We asked Dan what type of emergency he was dealing with. Dan responded well my daughter who is a nanny is missing and did not show up to her job.

Dan told us that his daughter [REDACTED] is also a substitute teacher and is working on her Master's Degree and that this is not like her. He said that they have called her cell phone, texted her and there has been no response. He added that she got up today in a normal fashion, left her bed unmade and then left the house as usual to go to work. We started asking Dan more questions about his daughter, her past, her jobs and her mental status.

After some questioning Dan leaned forward and said "I'm just going to be blunt with you guys ". I don't know if you guys are aware of the problems between the Township Supervisor and me. "He (Leo) is trying to run me out". "He has come into my office recently and appears to be losing it". "He has done this several times and I'm starting to fear for my life and my family's life ". "He (Leo) has people on his side that will do anything"! Then he added, I think Leo or one of his associates could be behind this, because there is no other explanation for her disappearance. She has not had a boyfriend in over a year so we have no stalker worries. "I think they grabbed her from her car ". I looked at Dan, his eyes were glossy and watery, he had a panicked look on his face and seemed like he was really struggling to come up with his answers.

I said to Dan that these are very serious accusations that you are placing against Leo. I then asked Dan "How credible do you really think your accusations against Leo are?" Dan replied "I believe it is very credible ". At this point we took Dan up to the command office to get further information and begin an investigation. We continued to ask Dan simple questions in reference to his daughter and he really struggled to answer simple questions, like her cellular phone number, cellular carrier, the name of the business she works for, etc.

I attempted to call [REDACTED] cell phone number that Dan provided; this call eventually went to her voice mail. Sgt. Weise attempted to look up the substitute teaching company that Dan stated [REDACTED] worked for which was Edu Serve. Sgt. Weise was unable to locate a company by that name. Dan then said "well it's the same service that Bloomfield Hills School District uses ". At this point Sgt. Weise called the Bloomfield Hills School District and ascertained the name of the substitute teaching company. The school district provided us with the name Edu Staff and a phone number. Sgt. Weise called the provided number and was told that [REDACTED] had accepted a job at Keller Elementary in the Royal Oak school district. Sgt. Weise then called Keller Elementary, spoke to the receptionist and was able to confirm that [REDACTED] was in fact working there today, however her assignment ended at 1200 hours.

Dan was satisfied with our findings and did not want any other follow-up done at this time. Dan thanked us for our assistance and said "let's keep all this stuff between us ".

At approx. 1600 hours Dan called into the command office. Dan wanted to let me know that [REDACTED] was home and the whole thing was a "texting miscommunication ". Dan then added "I also want to apologize for my "paranoid rant". I thanked Dan for the update, expressed that we were happy his daughter was safe and to have a good weekend.
